# Gymnastics Unlimited, Inc

## LIABILITY RELEASE

In consideration of the services of Gymnastics Unlimited, Inc./NinjaZone, herein and collectively referred to as "GU", their agents, owners, officers, employees, and all other persons or entities acting in any capacity on their behalf, I hereby agree to release and discharge GU/NinjaZone, on behalf of myself, my children, my parents, my heirs, assigns, personal representative and estate as follows: 1. I understand and acknowledge that the activity I, or my child, are about to engage in poses known risks and unanticipated risks which could result in injury, paralysis, death, emotional distress, or damage to myself or my child, to property, or to third parties. The following describes some, but not all, of those risks: Gymnastics training entails certain risks which simple cannot be eliminated without jeopardizing the essential qualities of the activity. WITHOUT A CERTAIN DEGREE OF RISK, GYMNASTICS STUDENTS WOULD NOT IMPROVE THEIR SKILLS, AND THE ENJOYMENT OF THE SPORT WOULD BE DIMINISHED. Gymnastics, use of a trampoline, and indoor wall climbing exposes its participants to the usual risk of cuts and bruises. Other more serious risks exist as well. Participants often fall off equipment, sprain or break wrists and ankles, and can suffer more serious injuries as well. Traveling to and from exhibitions raises the possibility of any manner of transportation accidents. In any event, if you are injured, you may require medical assistance, at your own expense. 2. I expressly agree and promise to accept and assume all of the risks existing in this activity. My participation in this activity is purely voluntary, no one is forcing me or my child to participate, and we elect to participate in spite of the risks. 3. I hereby voluntarily release, forever discharge and agree to hold harmless and indemnify GU/NinjaZone from any and all liability, claims and demands, actions or rights of actions, which are related to, arise out of, or are in any way connect with me or my child's participation in this activity, including those allegedly attributable to the negligent acts or omissions of GU/NinjaZone. 4. Should GU/NinjaZone, or anyone acting on their behalf, be required to incur attorney's fees and costs to enforce this agreement, I agree to indemnify and reimburse them for such fess and costs. 5. I certify that I, or my child, have health, accident, and liability insurance to cover any bodily injury or property damage that may be caused or suffered while participating in the event, or else I agree to bear the costs of such injury or damage to myself or my child. I further certify that I, or my child, have no medical or physical condition which could interfere with me or my child's safety in this activity, or else I am willing to assume and bear the costs of all risks that may be created, directly or indirectly, by any such condition.

In consideration of my child (a minor) being permitted by GU/NinjaZone to participate in its activities and to use its equipment and facilities, I further agree to indemnify and hold harmless GU/NinjaZone from any and all claims which are brought by, or on behalf of minor, and which are in any way connected with such use or participation by minor. By signing this document, I acknowledge that if anyone is hurt or property is damaged during my participation in this activity, I may be found, by a court of law, to have waived my right to maintain a lawsuit against GU on the basis of any claim from which I have released them herein. I have had sufficient opportunity to read this document. I have read, understood and agree to be bound by its terms. Any and all Ninja skills will be conducted in a safe environment and will hold Gymnastics Unlimited Inc. and NinjaZone harmless of any injuries incurred in and outside gym areas.

I confirm that my child is in good health. I authorize simple first aid and consent to medical examination and treatment by a physician if deemed necessary.

I hereby authorize Gymnastics Unlimited, Inc. and the NinjaZone to publish the photographs and videos taken of me and/or the undersigned minor children, and our names, for use in the printed publications, website, social media and training purposes. I release Gymnastics Unlimited, Inc. and NinjaZone from any expectation of confidentiality for the undersigned minor children and myself and attest that I am the parent or legal guardian of the children listed below and that I have the authority to authorize the use of their photographs, videos and names.
